Dear Senior Prescription Drug Assistance Program Member,

For CY2025, the Senior Prescription Drug Assistance Program (SPDAP) will continue to provide a maximum Premium Subsidy benefit towards your Medicare Part D premiums of \$75 per month.

It is important to remember that in addition to the annual Open Enrollment Period — Tuesday, Oct 15th through Saturday, Dec 7th — enrollment in the SPDAP offers members the added benefit of being allowed to change their drug plan one additional time during the calendar year.

The following two tables reflect both the 2025 Medicare Part D Advantage Plans and 2025 Medicare Part D Rx Plans offered in Maryland:

INFORMATION CONCERNING THE MARYLAND EARNED INCOME TAX CREDIT

The Maryland Earned Income Tax Credit (EITC) is a benefit for working people with low to moderate income. If you qualify for the Federal Earned Income Tax Credit and claim it on your federal return, you may be entitled to the Maryland EITC on your state return equal to 50% of the federal tax credit you have received. The Maryland EITC will either reduce or eliminate the amount of the state and/or local income tax that you owe.
