Member,

For CY2026, the Senior Prescription Drug Assistance Program (SPDAP) has increased the maximum Premium Subsidy benefit towards your Medicare Part D premiums to \$100 per month.

It is important to remember that in addition to the annual Open Enrollment Period — Wednesday, Oct 15th through Sunday, Dec 7th — enrollment in the SPDAP offers members the added benefit of being allowed to change their drug plan one additional time during the calendar year.

The following two tables reflect both the 2026 Medicare Part D Advantage Plans and 2026 Medicare Part D Rx Plans offered in Maryland:

INFORMATION CONCERNING THE MARYLAND EARNED INCOME TAX CREDIT

The Maryland Earned Income Tax Credit (EITC) is a benefit for working people with low to moderate income. If you qualify for the Federal Earned Income Tax Credit and claim it on your federal return, you may be entitled to the Maryland EITC on your state return equal to 50% of the federal tax credit you have received. The Maryland EITC will either reduce or eliminate the amount of the state and/or local income tax that you owe.
